## Highlights 2020

Dawei Fang was awarded the 2020 Hans Dalborg Award for excellence in financial economics research.

Martin Holmén received SEK 8.5 million from FORMAS for the project "Carbon footprints, climate risks, and finance professionals". It is a joint project with the environmental group at the Department of Economics.
