# THE QUALITY OF GOVERNMENT INSTITUTE

he Quality of Government (QoG) Institute was founded in 2004 by Professor Bo Rothstein and Professor Sören Holmberg. It is an independent research institute within the Department of Political Science at the University of Gothenburg. We are about 30 researchers who conduct and promote research on the causes, consequences and nature of Good Governance and the Quality of Government (QoG) - that is, trustworthy, reliable, impartial, uncorrupted and competent government institutions.

While Quality of Government is our common intellectual focal point, we apply a variety of theoretical and methodological perspectives. The main objective of our research is to address the theoretical and empirical problem of how political institutions of high quality can be created and maintained. A second objective is to study the effects of Quality of Government on a number of policy areas, such as health, the environment, social policy, and poverty. We approach



these problems from a variety of different theoretical and methodological angles. We investigate and generate knowledge on corruption and the quality of government in dialogue with a variety of societal actors, in both the public and the private sector. Our ambition is to close the gap between broader audiences and the research of QoG.



### THE OOG DATA

**As a key resource** for researchers and practitioners, QoG Data offers ten datasets, several data visualization tools, as well as tips and advice on how to use our data. Our goal is to enable researchers, academics, and students to access high quality information about the quality of government and related areas. Our datasets are presented as both cross-sectional and timeseries and in the most common data file formats.

## LETTER FROM THE DIRECTOR

2023 has been a year of important changes and of intense activities.

Marina Nistotskaya finished her successful directorship of the QoG Institute and passed me the torch on July 1st. Five young affiliates to QoG successfully defended their theses: Jana Schwenk, Adea Gafuri, Felicia Robertson, Dragana Davidovic, and Gefjon Off.

In terms of academic output, this has been a very productive year. An outstanding number of peer-review articles have been published by members of the Institute, in top journals within the social sciences (e.g. American Journal of Political Science, The Journal of Politics, British Journal of Political Science, Journal of European Public Policy) as well as in other disciplines (Nature Climate Change, The American Journal of Geriatric Psychiatry). In addition, 19 working papers were published within the QoG Working Papers series and made available on our website. Members of the QoG Institute have participated in numerous academic conferences and workshops during the year, including 10 paper presentations at the Annual Meeting for the American Political Science Association (APSA).

In economic terms, we keep a diversification of funding sources. Our funding agencies include Carl Bennet AB, The Swedish Research Council (Vetenskapsrådet, VR), Riksbankens Jubileumsfond (RJ), European Commission, European Research council (ERC), Swedish Research Council for Health, and Working Life and Welfare (FORTE). And, during this year, the Institute has received several new funds. Among them, we should underline the 8.1 million SEK major grant from Riksbankens Jubileumsfond for creating the Local Quality of Government (Lo-QoG) dataset, with Aksel Sundström as the PI. The ambitious goal of Lo-QoG is to become the leading worldwide platform on indicators of both local governance and its societal correlates. Aksel Sundström was also awarded one of Europe's most prestigious research grants, the ERC Starting Grant.

Last but not least, we have also hosted 5 ambitious and motivated interns for a period of 10–20 weeks: Alva Ohlsson, Anna Maria Kovalicka, Hampus Hallin, Jiuyang Li, Paula Nilsson, and Rasha Khoury. We wish them the best of luck in their future endeavors.

And this 2024, the QoG Institute turns 20. We celebrate the anniversary with an international conference on May 20–22 to both take stock of the accumulated knowledge as well as to discuss the avenues for further research. 

### COOPERATION WITH THE LANCET COMMISSION ON PEACEFUL SOCIETIES THROUGH HEALTH EQUITY AND GENDER EQUALITY

In 2023, the QoG Institute initiated a cooperation with the Lancet Commission on Peaceful Societies through Health Equity and Gender Equality. The Lancet Commission is an independent and interdisciplinary initiative of 20 Commissioners and other collaborators, originally set up in 2019 to explore the untapped intersections between Sustainable Development Goal (SDG) 3 for health and wellbeing, SDG 5 on gender equality, and SDG 16 for peace, justice, and strong institutions.

### Davidovic, Dragana

Public Attitudes Towards Environmental Taxation: The Interplay Between Values, Trust, and Quality of Government

**Environmental problems** are commonly understood to be rooted

in collective action dilemmas where the rational course of action for individuals is to engage in polluting activities to receive short-term benefits, while the long-term costs of those activities are borne by the collective. Voluntary cooperation to solve large-scale collective action problems such as climate change is unlikely.

Thus, state intervention is needed to enforce cooperation through implementation of various climate policy instruments. These tools are more likely to be successfully and effectively implemented if they are supported by citizens. Policy experts argue that environmental taxation is the most effective way to mitigate climate change; however, public support is lacking. This dissertation investigates whether the institutional context, specifically perceptions of low quality of government (QoG), moderates the link between individuals' pro-environmental and political-ideological value orientations and climate policy attitudes. Analyzing cross-sectional and original survey experimental data, the dissertation examines if quality of government shapes the climate policy attitudes of citizens, and through what mechanisms. The analyses show that perceptions of poor institutional quality lower trust in political actors and institutions, and generate negative climate policy attitudes even among those who otherwise hold pro-environmental values and concerns and favorable attitudes towards government regulation. The dissertation contributes to an improved understanding of the determinants of climate policy attitudes and more informed recommendations for policymakers, and will hopefully also inspire further research on how institutional factors affect the prospects for effective climate policy.

### Gafuri, Adea

Aid by Democratic Versus Autocratic Donors: Democratization Processes and Citizens' Perceptions in Recipient Countries

**OECD countries** are no longer the sole major providers of financial flows abroad. Authoritarian countries such as China, Russia, Iran, and Saudi Arabia, with their distinct practices and implementation processes, are increasingly present in low- and middle-income countries. In this Ph.D. dissertation, I develop and test hypotheses on the influence of

foreign aid on democratization processes and citizens' attitudes in recipient countries. Employing a multimethod approach, using observational and experimental methods, I analyze the role of democratic donors such as the European Union (EU) and autocratic donors like China, both together and separately. I find that democratic donors like the EU, who target democratic institutions via democracy assistance can foster democratization. I argue that democracy assistance is effective when aid is coupled with political conditionality and monitoring mechanisms. On the other hand, aid from autocratic donors like China can decrease support for democracy, especially among those who view autocratic donors very positively. Autocratic aid impacts these perceptions through (1) attribution processes, i.e., individuals learn about aid projects that are implemented close to where they live (2) the instrumentalization of aid by political elites, i.e., political elites influence citizens by spreading information about the benevolence and generosity of authoritarian donors. Finally, this Ph.D. dissertation demonstrates that foreign donors' attributes convey to citizens how likely corruption is in the project and how responsive their local government and donors will be in implementing such projects. The political regime of the donor, whether democratic or autocratic, signals the level of responsiveness to citizens' demands. On the other hand, whether a donor is transparent or not, indicates the risk of corruption in the project and in the local government.

### Off, Gefjon

Contested Feminism: Backlash and the Radical Right

During the past decade, various societies have observed feminist mobilizations and antifeminist counter-mobilizations, the latter being partly driven by radical right parties. Even in societies marked by institutions and norms that should be most conducive to progressive gender equality and LGBTQI+ norms, feminism is a point of contestation.

Through a compilation of five papers using multiple methods, this dissertation investigates the contested nature of contemporary feminism across different European contexts. Specifically, the papers examine a) conservative/ liberal polarization over feminism; b) the effect of (anti) feminist attitudes and feminist issue salience on radical right voting; c) radical right voters' (anti)feminist attitudes; d) young men's perceptions of feminism as a threat; and e) radical right voters' cultural grievances over feminism. Theoretically, I apply research on issue salience and threat perceptions to the study of attitudes toward feminism. Methodologically, I analyze existing and originally collected, experimental and observational data from surveys and interviews. In doing so, I theoretically and empirically contribute to research on cultural backlash, radical right voting, mass ideological polarization, antifeminism, and sexism. I find that people who oppose or counter-react against certain progressive gender and sexuality issues tend to vote for the radical right and distrust institutions. Demographically, they tend to be young men living in regions with increasing unemployment. They particularly oppose gender and sexuality issues that are salient in the public debate and evoke threat perceptions. Based on the findings, I develop a framework that may serve as guidance for future research on socially conservative backlash, as well as liberal-conservative polarization.

Political trust is crucial for a wellfunctioning society. Yet few countries
enjoy the benefits of high political
trust. This makes people wonder
how trust in institutions is built.
While trust in political institutions
is considered to be an individual's
evaluation of institutional
performance, individuals within
the same country make very different

assessments. In this dissertation, I show that personality traits, that are genetic and socialized at an early age, can help explain why individuals' trust assessments differ. As personality traits reflect individuals' behavioral, cognitive, and emotional patterns, I argue that traits affect

political trust in three ways, directly through our general tendencies, indirectly through how we process information and experiences, or how we interact with institutions. In three research papers, I study the relationship between personality traits and political trust in different political contexts, using different measurements of personality traits, political institutions, and institutional experiences. The results show that personality traits contribute to explaining why individuals' levels of trust in the same institutions differ. I conclude that personality traits are an important explanation for how political trust is formed and need to be considered when studying how trust changes over time.

Beyond the Party's Realm – The Consequences of Variation in Candidate Selection

In the last two decades, Western
European parties have introduced
various methods to select candidates
for executive public office. A
process that before was mainly
the privilege of a narrow elite
was opened to party members
in several parties. While research
extensively investigated the effects
of variation in candidate selection on

parties, little is known about the effects that variation in candidate selection has on voters and whether the effects are gendered. The dissertation argues that candidate selection has consequences beyond the party and explores in four research articles how variation in candidate selection affects voters' corruption perceptions, their evaluations of candidate quality, female representation, and gendered effects of evaluations of corruptibility. Overall, the results suggest that the consequences of variation in candidate selection are far-reaching, highlighting the importance of considering the impact of candidate selection and intraparty democracy more generally on outcomes beyond the party. The research articles in the dissertation demonstrate that candidate selection can affect corruption perceptions, evaluations of valence, and female representation. Not only does this dissertation demonstrate the need to consider the effects of intraparty dynamics on factors outside of the party, but it also illustrates how previous literature on each of the outcomes investigated in the dissertation fell short of considering intraparty democracy as an explanatory factor. Given the results of this dissertation, future research should thus focus more strongly theoretically and empirically on the effects of intraparty dynamics.

# RESEARCH GRANTS 2023

In 2023, QoG researchers managed to secure funding for many new projects, not least a major grant on 8,1 million SEK from Riksbankens Jubileumsfond for creating the Local Quality of Government (Lo-QoG) dataset: A hub for local societal indicators across Europe (PI Aksel Sundström). The ambition of Lo-QoG is to become the leading platform on indicators that relates to local governance and its societal correlates, broadly defined. Another major achievement was that Aksel Sundström was granted the ERC Starting Grant, which is one of Europe's most prestigious research grants, awarded by the European Research Council (ERC). The EUR 1.5 million grant runs for five years and is aimed at researchers at the beginning of their careers with the aim is to promote the top researchers and the best ideas.



### **MISCONDUCT AND WHISTLE-BLOWING IN POLITICAL PARTIES**

The aim of this project is to identify and examine the mechanisms of whistleblowing in political parties. Whistleblowing, understood as insiders' disclosure of illegal, immoral, or illegitimate practices of an organization is generally recognized as a key process through which government institutions and corporations are held accountable. Still, we know little of this process in one of the most central institutions of democracy: the political parties. Bringing together the literatures on party research and the research fields of whistleblowing and corruption, we pose two sets of research questions: 1) What types of misconduct occur in political parties and to what extent do these practices take place? 2) How, by whom, and with what results is whistleblowing used to reveal these misconducts? The project provides an in-depth empirical knowledge into hitherto hidden processes of misconduct and inter-party accountability by analyzing surveys sent to political representatives in Sweden and by carrying out a large number of qualitative interviews with Swedish politicians, party members, civil servants, and journalists. Upon the conclusion of the project in 2025, our results will inform the discussion on the role of political parties in generating and sustaining good governance. They may also spark a debate about transparency and whistleblowing protection in party organizations.

### **SUSTAINING STATE CAPACITY** IN A MODERN STATE: CITIZEN-**STATE RELATIONS AND VOLUNTARY COMPLIANCE IN SWEDEN**

Sweden is a high-capacity state. But there are worrying signs of declining state capacity and the reach of the state varies alarmingly between different parts of Sweden. The Police's list of "vulnerable neighborhoods" illustrates both problems. One reason for the situation is that many citizens are unwilling to comply with the state. In our project we will map citizens' willingness to comply with the state at the subnational level and explain the variation we find. High-capacity states' ability to implement policy build on that citizens are willing to comply with its decrees. Sweden has in recent years received many citizens from countries in which the state exercises its power through coercion and violence. We believe that these citizens are less willing than native born citizens to comply with the state's decrees. To map their and other citizens' willingness to comply we will collect survey data among citizens and street-level bureaucrats who interact with citizens daily and analyze register data on voluntary visits to child health controls. We will also study how the state can build compliance among citizens who are unwilling to comply. We believe that interactions with bureaucrats are crucial for fostering compliance. We will therefore conduct survey experiments in which we match bureaucrats' characteristics with citizens' backgrounds to study how it affects citizens' willingness to comply. In all, the project aims to improve relationships between citizens and the state.

### **DOES ADVANCING WOMEN'S EMPOWERMENT LEAD TO** PERCEPTIONS OF THREAT? **RESEARCH ON WHO IS THREATENED BY WOMEN'S EMPOWERMENT, UNDER WHAT CONDITIONS AND WHY**

The main guiding research question of this project is: what generates, fosters or reduces perceptions of advancement in women's empowerment as threatening in Western democracies? Conventional wisdom suggests that older generations are more inclined to oppose societal changes that advance gender equality, yet in our recent publication, we find that young men are most likely to perceive advances in women's rights as threatening across Europe. Building on this study, the project aims to, one, identify which demographic groups are most likely to perceive advancements in women's empowerment as threatening over time, and two, what motivates such threat perceptions. Moreover, we aim to explain what role intervening factors – such as competition, issue framing, elite cues and social media – can play in mitigating perceived threats. Novel survey data from the upcoming rounds of the European Social Survey and the European Quality of Government (EQI) Survey and data freely available over time from other existing surveys will be analyzed. We will also design and field a pan-European randomized survey experiment in the next EQI round, testing various threat perceptions. The project will also conduct qualitative interviews in areas in Europe with selected groups that are most likely to perceive women's empowerment as a threat, specified from the findings of the large-N empirical studies to provide more nuance and depth to the overall findings and eventually policy recommendations.

Fem-LEAD (Female Leadership and Effects from African Droughts) aims to understand the connections between weather-related disasters and women's standing in politics in African countries. It challenges present scholarship by proposing a new link between climate change and gender: What if weather-related disasters, such as droughts, risk hurting recent advances of women as political leaders in African countries? Focusing on droughts, public opinion and political representation, its objective is to gain theoretical and empirical insights of links between weather-related disasters and women's political standing. The project will also involve two-three postdoctoral researchers and a research assistant.

### FIGHT AGAINST LARGE-SCALE CORRUPTION AND ORGANISED CRIME NETWORKS (FALCON)

Funder: European Commission Horizon Europe

Marina Nistotskaya (PI), Carl Dahlström have received a Horizon grant of for their part in the project Fight Against Large-scale Corruption and Organised Crime Networks (FALCON). The lead organization is Erevnitiko Panepistiliako Instituuto Systimation (Greece).

Current evidence suggests that the global fight against corruption faces serious challenges: policy decisions are not well informed, the corruption landscape is complex and enormous, while measuring corruption is so far mostly based on subjective approaches, and there is lack of appropriate technological tools to support anti-corruption. To address these challenges, FALCON is designed and dedicated to support the composition, update and management of comprehensive corruption intelligence pictures, within domains and jurisdictions of interest. This will be accomplished following a multi-actor, evidence-based, data-driven approach, building upon existing assets and prior work of consortium partners. FALCON will, first, develop and validate objective and actionable indicators (individual and composite) of corruption that can be used to inform policy decisions. Second, it will design, implement and integrate powerful data analytics tools, data pipelines and applications that support the management of the entire lifecycle of corruption intelligence pictures. This will enable comprehensive corruption risk assessment, informed policy making, and improved anticorruption law enforcement. FALCON will be piloted in four corruption domains - corruption schemes at border crossings, sanction circumvention by kleptocrats/oligarchs, public procurement fraud, conflicts of interest of politically exposed persons (PEPs) – involving law enforcement experts (police authorities and border guards) from six (6) European countries and other key actors (i.e., GovTech providers, academia, financial intermediaries, policy makers, NGOs, and civil society).

FALCON's implementation will be incremental and iterative, forming synergies between SSH and technological expertise, and will adhere to the principles of Trustworthy AI and responsible research and innovation. Lastly, FALCON has defined specific key exploitable results and performance indicators for measuring its progress and success.

The Quality of Government Institute is a partner, together with the consultancy firm ECORYS (PI) and the research network ICRN, in the successful bid to consult the EU Commission DG Migration and Home affairs on matters related to the fight against and prevention of corruption. The general objectives of the projects are to support the EU's anti-corruption efforts, consisting of six pillars:

- Mainstreaming anti-corruption provisions in EU horizontal and sectorial legislation and policy;
- Monitoring performances in the fight against and prevention of corruption by Member States in the framework of the annual EU Rule of Law Report;
- Supporting the implementation of anti-corruption measures at national level via funding, technical assistance and experience-sharing;
- Improving the qualitative evidence base for anti-corruption policy;
- Promoting the fight against and prevention of corruption globally, through the participation in relevant international anti-corruption meetings; and
- Updating and modernising the EU anti-corruption framework.

# ACTIVITIES IN 2023

In 2023, we continued to run our regular activities, such as our much-appreciated visiting scholar program, lunch seminar series, internal conferences, and internship program. We also organized a policy day on the topic of "Corruption and Quality in the Welfare State: Opportunities and Challenges of the Swedish System", which brought together a mix of practitioners from the public, private and non-profit sectors, leading to a very interesting policy dialogue on corruption in welfare states.

uring the year, we hosted 11 visiting scholars and an additional three lunch seminar guests who all presented their research at a lunch seminar. One of them was the 2022 Best Paper Award winner Gustav Agneman, Postdoctoral researcher at Lund University, who presented his award-winning paper: "The Uneven Reach of the State: A Novel Approach to Mapping Local State Presence."

QoG scholars also presented their work at several academic conferences and workshops and were and engaged in a number of activities directed towards the academic world as well as the public and policymakers. For instance, in February and March, QoG arranged a series of lectures on "Corruption as a societal problem" (in Swedish: "Korruption som samhällsproblem") at the Gothenburg Senior University, involving talks by several of our researchers. QoG also participated with an exhibition booth, and a much-appreciated reception, at The American Political Science Association Annual Meeting & Exhibition, APSA, in Los Angeles, together with the V-Dem Institute, Governance and Local Development – GLD, and the department of Political Science at the University of Gothenburg.

### QoG internal conferences

Every year, the QoG Institute organizes two internal conferences. Our internal conferences allow participating scholars to present papers and new ideas in a familiar yet highly professional and critical environment. Many of the conference contributions are published in our working paper series and/or published in peer-reviewed journals.

## QOG BEST PAPER AWARD

he Quality of Government (QoG) Institute's Best Paper Award is an annual prize awarded to a paper on a quality of government related topic, demonstrating outstanding research based on its theoretical and empirical contributions.

Christoffer Cappelen & David Sjöberg, with their paper: "The Uneven Reach of the State: A Novel Approach to Mapping Local State Presence." This semester, we had the honor to host him as visiting scholar and to listen to a presentation on his awardwinning paper.

### Motivation:

The paper offers an innovative and fine-grained measure of state reach at the local level, an endeavor which will increase the validity and viability of research on the determinants and effects of state presence in both scholarly and policy research moving forward. The paper is theoretically rich and synthesizes survey data with satellite imaging and uses machine learning to develop measures of predicted state presence in Sub-Saharan Africa. The authors then validate the measure through vaccination rates and census accuracy and go on to show that state presence predicts the likelihood that oil extraction leads to violent local conflicts. The paper provides a clear and comprehensive description of the method, which will allow replication to create similar data for other geographic regions. In sum, the paper greatly improves on existing approaches to measuring state reach, and thereby paves the way for more rigorous investigations of the sources of state density as well as its implications for a range of societal outcomes.

### **DEMSCORE**

The QoG Institute is a partnering institute of the Demscore (acronym for research infrastructure for Democracy, Environment, Migration, Social policy, Conflict, and Representation), which is a an innovative e-infrastructure that brings together some of the world's leading research infrastructures and databases, with the aim to provide free access to harmonized data from several of the world's largest datasets on Democracy, Environment, Migration, Social Policy, Conflict, and Representation. Demscore is a collaboration between the universites in of Gothenburg, Stockholm, Uppsala, and Umeå. The project is funded by the Swedish Research Council.

In 2023, the first full version of the DEMSCORE platform was launched and research findings from DEMSCORE partners were presented through seminars, panel discussions, and workshops.

# THE LANCET COMMISSION ON PEACEFUL SOCIETIES THROUGH HEALTH EQUITY AND GENDER EQUALITY

In 2023, the QoG Institute initiated a cooperation with the Lancet Commission on Peaceful Societies through Health Equity and Gender Equality. The Lancet and the Swedish Institute for Global Health Transformation (SIGHT) launched the Commission on Peaceful Societies through Health and Gender Equality in 2019. The Commission is an independent and interdisciplinary initiative of 20 Commissioners and other collaborators, originally set up to further the 2030 Sustainable Development Agenda and to explore the untapped intersections and opportunities between the Sustainable Development Goals (SDGs) for health and well-being (SDG 3), gender equality (SDG 5), and peace, justice, and strong institutions (SDG 16). The QoG Institute, represented by Assoc. Prof. Amy C. Alexander, was involved in this transdisciplinary collaboration, which culminated in a report from the Commission published in the Lancet in November of 2023. This research generates novel, robust evidence based on global, longitudinal analysis of countries and case studies of countries that supports health equity, gender equality and peace as mutually reinforcing and pinpoints improvements in health equity and gender equality, in particular, as fundamental to countries achievements of greater and more sustainable peace.

# QOG DATA

In 2023, our data team grew and we are happy to welcome Rafal Lopez Valverde as Data Manager. Aksel Sundström, who is leading the QoG Data operation, also managed to get funding from Riksbankens Jubileumsfond for creating the Local Quality of Government (Lo-QoG) dataset: A hub for local societal indicators across Europe. The ambition of Lo-QoG is to become the leading platform on indicators that relates to local governance and its societal correlates, broadly defined. Thanks to this funding, the QoG Data team will grow with two new positions in 2024.

## **QOG DATA**

In 2023, the QoG Data Team made significant progress, by updating the Compilation Datasets and by increasing the number of data sources. For the 2023 update, our compilations gathered 2087 variables from 122 sources. Enhancing our data collection further, we incorporated these eleven new data sources:

- Quota Adoption and Reform over Time (QAROT), 1947-2015 (Hughes, Paxton, Clayton & Zetteberg, 2017). This dataset is the first longitudinal dataset with information about the adoption, implementation, and reform of national gender quotas across the world.
- Change in Source of Leader Support (CHISOLS) Data (Mattes, Leeds & Matsumura, 2016). The goal of this dataset is to differentiate leader transitions in which a new leader comes to office who depends on different societal groups for support than their predecessor from leader transitions where both the current leader and their predecessor rely on essentially the same groups for support.
- Global Data Governance Map (Struett, Zable & Aaronson, 2022). This dataset focused on how governments around the world govern data on six different attributes: strategic, regulatory, responsible, structural, participatory and international.
- Informal Economy Database (Elgin, Kose, Ohnsorge & Yu, 2021). This database includes up to 196 economies over the period 1990-2018 and includes the twelve most commonly used measures of informal economy.
- Global Tax Expenditures Database (Redonda, von Haldenwang & Aliu, 2022). This dataset brings together the official and publicly available data on tax expenditures as published by national governments since 1990.
- Historical Index of Ethnic Fractionalization (Drazanova, 2019). The HIEF Data contains an ethnic fractionalization index for 165 countries across all continents. The dataset covers annually the period 1945-2013.
- Multidimensional Index of Bureaucratic Underrepresentation (Cingolani, 2022). This dataset presents a time-series cross-sectional Index of Bureaucratic Underrepresentation (IBU) covering a total of 37 European countries between 2008 and 2018.
- Enterprise Surveys (The World Bank, 2022). The World Bank Enterprise Surveys offer an expansive array of economic data on 180,000 firms in 154 countries.
- WJP Rule of Law Index 2022 (World Justice Project, 2022).
   This dataset measures how the rule of law is experienced and perceived in practical, everyday situations by the general public around the world.
- The World Uncertainty Index (Ahir, Bloom & Furceri, 2022). The WUI dataset reflects the frequency of the word uncertainty in the quarterly Economist Intelligence Unit country reports.



QoG Data offers open-access datasets, so users can learn, research and understand better the concepts relating to Quality of Government.

- The GenDip database on Gender and Diplomatic Representation (Niklasson & Towns, 2022). The purpose of this dataset is to provide information on the gender of diplomats around the world.
- The Data on Central Bank Independence (Romelli, 2022).
   This dataset provides information on a comprehensive index of CBI covering a wide range of central bank characteristics based on the charters of 154 central banks over the period 1972–2017.

During the year, we received a substantial engagement, with a total of 76,460 downloads of our data. The QoG Standard Dataset, Time-Series 2023, stood out as the most sought-after dataset. Our user base is notably international, with the majority visiting from the United States, complemented by significant representation from Western Europe. Within our Data Finder, the topics of corruption, democracy, and education garnered the most interest, while the ICRG Indicator of Quality of Government (icrg\_qog) variable emerged as the most frequently searched variable.

At the beginning of the year, we received exciting news; Aksel Sundström and Marina Nistotskaya were awarded an 8.1 million SEK infrastructure grant from Riksbankens Jubileumsfond to support 'The Local Quality of Government (Lo-QoG) dataset: A hub for local societal indicators across Europe' project. The project aims to develop a dataset at the local/municipal level, which we anticipate will contribute to a more nuanced understanding of governance quality and societal conditions at the community level across various European regions. Additionally, this grant offers us an invaluable opportunity to expand our data team.

In 2023, our commitment to connecting with the research community was further strengthened through a variety of outreach initiatives. A key highlight was our participation in APSA 2023, held in Los Angeles, where we showcased our freely available resources to the political science community. Our exhibition booth, jointly hosted with GLD and V-Dem, was quite fruitful in terms of receiving feedback and suggestions from existing users and engaging with new individuals interested in utilizing our data collection and visualization tools for diverse research purposes.

In August, a group of PhD students from Oslo visited our department, and we presented our work and fostered collaborative discussions, which enriched our perspective and highlighted the practical applications of our data in academic research. We also continued our educational outreach by presenting in the 'Introduction to Applied Research Design and Quantitative Research Methods for Social Scientists' course, showcasing the QoG datasets and online tools to bolster students' quantitative research skills.

During the Fall semester, our team was pleased to welcome Paula Nilsson, a master's student from Lund University, who joined us as part of the ongoing data internship program we launched last year. Paula made valuable contributions in the preparation of the latest update of our compilation datasets. Furthermore, she designed an interactive dashboard titled "Share of Right-Wing Parties in Europe," which is now accessible on our website and offers an insightful data representation to our users.





## QOG MASTER COURSES

**Master students** at the University of Gothenburg have an opportunity to take part in courses that specifically explore different aspects of quality of government and the performance of democracies from a "governance" perspective.



## THE PERFORMANCE OF DEMOCRACIES

This course explores factors that explain cross country variation in democratic performance and their implications. More specifically, it is concerned with how institutional variation among democratic regimes is related to outcomes in general dimensions of performance, such as, human well-being, corruption and sound management of public finances, among others. It therefore takes a quality of 'governance' perspective, focusing on why and how democracies 'succeed or fail'. You also get to study the implications that follow for citizen attitudes and democratic support.

In 2023, 22 students were enrolled on the PERDEM course.

## THE QUALITY OF GOVERNMENT IN A COMPARATIVE PERSPECTIVE

The course addresses problems related to the quality of governance (QoG) and corruption in a comparative perspective. Today, there is consensus among social science researchers about the importance of high-quality government for economic and democratic development as well as for social and environmental sustainability. Government organisations that are trustworthy, reliable, impartial, uncorrupted and competent are currently seen as one of the most important factors of human wellbeing. Corruption is seen as having detrimental effects on economic growth, the public goods provision, the democratic processes and trust among citizens. The quality of governance is not a problem for developing countries only but exists also in economically developed democracies where trust in government institutions and the sustainability of welfare programs has been questioned. The central issues that we address in the course are: What is QoG? How can QoG be defined and measured? What explains the great variation between the countries in QoG? What do you get from high QoG and what are the mechanisms that give high/low QoG?

In 2023, 24 students were enrolled on the QoG course.

### INTERNSHIP PORTRAIT OF JIUYANG: MY JOURNEY AT THE QUALITY OF GOVERNMENT (QOG) INSTITUTE

As a political science major in the second year of my master's program, deeply intrigued by the complexities of global governance, I embarked on an internship at The Quality of Government (QoG) Institute. Filled with excitement and curiosity, I stepped into the role of a Research Assistant Intern, viewing it as both a gateway into the world of political research and a critical milestone in my academic journey.
