#### Introduction

Centre for Health Governance (CHG) was established by the University of Gothenburg vice-chancellor November 1, 2021. The centre is a joint effort by the School of Business, Economics and Law and the Sahlgrenska Academy, with the **purpose**:

 To generate applicable knowledge with significance for the health care sector. This is to be achieved by networks in which researchers, care providers, and the business community are included.

#### Organization

Centre for Health Governance (CHG) follows the regulation and policy set for centres at the University of Gothenburg. CHG has its administrative base at the Department of Economics, School of Business, Economics and Law. Director and deputy have been appointed, a management team formed and a webpage has been set up. A steering group has been appointed by the vice-chancellor, with members according to regulations for University of Gothenburg centres. The steering group consists of representatives from Sahlgrenska Academy, departments within the School of Business, Economics and Law and external member from the Region Västra Götaland (VGR). The steering group has had two board meetings spring semester and another two planned for fall. An operative management group was formed initially with representatives from the departments involved from the School of Business, Economics and Law and the School of Public Health and Community Medicine at the Sahlgrenska Academy. Regular meetings have been held once a month. An advisory board for external collaboration is being formed, in which both local business and public community within the health area will be included.

We have decided to focus the research on health governance for CHG to six areas:

- 1. Medical technologies and treatments: effects of new treatment methods
- 2. Healthcare of the future: digitalization and AI
- 3. Mobilization of new funding models for preventive health ecosystems; primary care, preventive care, and compensation models
- 4. Standardized care processes and knowledge management
- 5. Universal health coverage Financial risk protection
- 6. Management practices for health promotion and sustainability within working life
