



**KAH050 Qualified Work Placement with a Humanities Perspective, 15 credits**

**Information about the course KAH050 Qualified Work Placement with a Humanities Perspective, 15 credits, autumn semester 2026**

Qualified Work Placement is a course where the student spends most of the semester in part-time work practice. In order to apply to the course is a minimum of 150 credits required (equivalent of at least 2 1/2 years of academic studies), including a thesis of at least 15 credits at bachelor's level in one of the main areas of the Faculty of Humanities. That means that the student is well prepared for qualified working tasks. These can consist of for example investigations, evaluations, arrangements, information work, translation assignments, language reviews, museum work, excavation work or other forms of cultural assignments in general.

At the location of the internship, the student needs during the internship period to have a contact person, a so-called internship host. The internship host shall, together with the trainee, discuss and agree on the assignments the trainee will carry out during the internship period, which shall be briefly stated in an internship plan. The internship plan shall in short describe the intended work assignments and an independent individual internship task the trainee shall work with during the internship period, as well as how the trainee will be given opportunities to solve their internship tasks. The trainee will bring a simple template for how such a practice plan might look like. The internship plan is signed by the internship host and the trainee and then sent by the trainee to the course supervisor for approval. If changes regarding assignments occur, the internship plan can be revised. It is an advantage if the internship plan is ready at the beginning of the internship period.

The internship period is from week 36 to week 51, 2026. During this period, the trainee will follow your working hours on part-time, as long as no other agreements have been made. However, we would like to see that the trainee has about 2–3 hours a week to read course literature, participate in one mandatory online discussion, participate in one mandatory online seminar and write an internship report. So that both parties get the best possible exchange of each other during the internship, it is recommended that you as an internship host during the internship period have regular reconciliations with the trainee about the internship once a week or every second week. It is also an advantage if the trainee's tasks are mediated through one person.

The course goes on from week 36 to week 2, 2027. After the internship period, the trainee will complete an internship report that will be presented at a seminar at the end of the autumn semester in week 2. In the internship report, the trainee is expected to describe

their work tasks during their internship period and reflect on the relevance and significance of humanistic competencies in working life. To the report, the trainee shall also attach an appendix with examples of work assignments and the independent individual internship task that the trainee worked with during the internship period.
