1 Time Schedule for Applications

Students' application deadline to International Office: **December 1, 2024**

2 Evaluation Criteria

- Only students from the Master of Science program in Economics can apply.
- Application must include a specification of your field of interest and, if possible, a topic for their thesis.
- Selection of students is made by the International Office and Graduate School based on Academic records from Term 1 (Autumn 2024).
- Applicants must have completed 22,5 hp (credits) by the time of nomination.

3 Eligibility to participate (before departure)

- Students must have successfully completed at least **37,5 ECTS** prior to starting the study at Hokkaido University. (Students who only have 37,5 ECTS before coming to Hokkaido need to take additional optional courses at Hokkaido. Those who have 45 ECTS are not required to do so)
- Each student must complete and submit one single-authored master thesis.

4 Exchange Period: 1st April 2025 – end of January 2026

- Spring semester: 1 April – 1st or second week of August (lectures only until last week of July)
- Autumn semester: Last week of September or first week of October – Last week of January

Courses from GU can be transferred max. 15 credits at HU

*Optional courses

Only Courses (B) or course package (A+B) are approved as optional course for GU students. Totally 12-16 credits incl. at least 6 credits from courses (B) are required during the spring semester of the first year and the autumn semester of the second year.

**** Students who only have 37,5 ECTS before coming to Hokkaido need to take additional optional courses at Hokkaido. Those who have 45 ECTS are not required to do so.**

*** The thesis awards 30 hp at GU and 16 credits at HU.

The GU students should be made aware that they need to start writing their thesis during the autumn semester of the second year to be able to complete the 30 ECTS thesis in time for GU graduation.

Choices and restrictions

GU-students going to HU must take two seminars at HU.

No option at GU (Only core courses)

Optional Courses at HU

Optional courses can be taken at any time, depending on availability.

GU-students going to HU must take Mathematics, Advanced Microeconomic Theory I, Graduate Econometrics, and Advanced Macroeconomic Theory at GU and cannot take the courses corresponding these at HU.
