

***The Bromanska stiftelsen för forskning och företagande, announces through the School of Business, Economics and Law at the University of Gothenburg***

**SIX SCHOLARSHIPS OF 267,000 SEK EACH  
FOR SCIENTIFIC RESEARCH FOCUSING MAINLY ON ENTREPRENEURSHIP**

The scholarships are intended for scientific research, mainly focusing upon entrepreneurship in a broad sense, as linked to the research areas at the School of Business, Economics and Law at the University of Gothenburg. Three of the scholarships are aimed specifically at candidates in the areas of entrepreneurship and innovation, and entrepreneurship in university-industry relationships. We encourage post-doctoral scholars as well as senior researchers to apply, but at least half of the scholarships are intended for post-doctoral scholars. Both international and locally based applicants are encouraged to apply.

This research shall start during 2015, with the School of Business, Economics and Law as the base and environment. The recipients will be expected to present their research in connection with events at the School of Business, Economics and Law, and also to participate in various networks in Sweden and abroad.

Post-doctoral scholars should have completed their doctorates during the last 6 years. Applications can be submitted before the public defense has taken place but the doctoral diploma must be issued and the research initiated before the end of 2015. The scholarship is sent to the individual, but the department must agree to support additional costs, such as office and IT.

For senior researchers special priority is given to projects which stimulate the internationalization of high quality scientific research in the field of entrepreneurship. The research should have its base at the School of Business, Economics and Law. If the recipient is permanently employed at the School of Business, Economics and Law the scholarship is paid to the department and cannot be used as salary. The department must agree to pay additional costs (medfinansering). Maximum 20 % of the scholarship can be used for overheads.

For all applicants, a supporting letter from the head of a department at the School of Business, Economics and Law must be included. According to the Statutes of the foundation it is possible for the holder to receive the scholarship on a maximum of three occasions. The decision on prolongation is based on an annual review of the performed research.

The application must include a description of the research project (max 5 pages). In addition, the applicants need to also submit a personal letter, CV, transcript and/or proof of degrees. For postdocs two letters of recommendations should also be enclosed. Applications should be addressed to *Bromanska stiftelsen för forskning och företagande* and sent to the Faculty Administration Office at the School of Business, Economics and Law, Box 601, SE-405 30 Gothenburg, Sweden.

Applications must be received by us by Friday, **30 September 2015 at the latest**. *Bromanska stiftelsen för forskning och företagande* plans to make its decision on recipients in October 2015.
