## Ongoing Research Projects

---

Gothenburg’s 1968: Stories from a working class city in movement (Göteborgs 1968: Berättelser från en arbetarstad i rörelse)

This project is an oral history project to collect the experiences and recollections of individuals active in Gothenburg’s 1968 activism, which spanned anti-war, feminist, communist, decolonization, student, and anti-fascist movements. The first year of this project, which is financed by a generous grant from the Ahrenberg Foundation, is dedicated to doing the initial archival research that will lay the groundwork for interviews, which will start in January 2025. The project includes the organization and creation of a finding aid for the Swedish Women’s Leftist Organization (SKV), an archive housed at KvinnSam, the National Library for Gender Research.

The future of women’s and gender research?

Swedish archival institutions today are confronted with a number of important challenges. Many of these are connected to the digitization of society, a shift that changes what an archive is and undermines long-standing archival traditions, not least for personal archives and social movements. For institutions focused on women’s and gender history, this situation is even more complicated. How can archives adapt to developments in women’s and gender history that highlight the importance of inclusivity and queer perspectives? Which donations should be prioritized, in order to ensure the future of archives-based women’s and gender research? A grant from Riksarkivarie Ingvar Anderssons fond will facilitate the start of a network for researchers and cultural heritage practitioners interested in these questions.
