## SUMMARY

I am Robin van Haastrecht, a third year PhD student under the supervision of Genkai Zhang. I am broadly interested in representation theory, some special interests being Wehrl type inequalities for matrix coefficients of unitary representations of real semisimple Lie groups and compact groups, and branching problems for representations of the Lie algebra  $\mathfrak{g}_2$  and the connected Lie group  $G_2$ . My first articles as a PhD student are about limit formulas connected to this Wehrl inequality. I want to continue to study this in the context of Hermitian symmetric spaces.
